- to be able to describe the librarians' responsibility and ethical code when facilitating access to community information in different library environments
- to be able so search, evaluate and present international research in community information

#### **concerning *skills and abilities***

- to be able to explain and navigate amongst public informationssources and documents
- to be able to manage to do a search duty in community information for an user

#### **concerning *professional judgement***

- to be able to evaluate different types of information sources in community information

### Forms of Teaching

Teaching is run by laboratory work, written assignments, seminars, lectures and project works.

The language of instruction is English.

## **Forms of Examination**

The course is examined through written assignments, seminars and reports.

Seminars can be replaced by other forms of examination specified in the course syllabus if a student has failed to fulfil the seminar requirements or has been absent.

In the event of changes in course plans students who wish to complete courses can be examined on the basis of the most recent version of the course plan. For courses that are no longer running, students who wish to complete such courses can read all or part of an equivalent course.
