### Content

The course aims to provide a basic aesthetic perspective on the historical development of clothing and textiles in relation to studies of form, material and concepts by studying reconstructions, sketches and texts. The main content of the course is as follows:

- Textiles, costume and the history of clothing from ancient times to the present day.
- Western clothing and textile design during the 18th to 21st centuries.
- Contemporary fashion and textile design, art and craftsmanship.
- Design and construction analysis of textiles or garments.
- Sketches and reconstruction of textiles or garments.
- Searching for information.

### Learning Outcomes

After completing and passing the course, students should be able to:

1. describe, relate, and reflect on silhouettes, materials, patterns, colour, and formative development of different epochs in text and image as well as practical design work,
2. demonstrate interdisciplinary knowledge of the history of textiles, clothing and design,
3. identify the design language of different epochs and designers as well as independently study and analyse design works through practical design work, sketches and conceptual studies, and reconstruction.

The main focus of the course is on learning outcomes: 3a-b and 4a-b.

### Forms of Teaching

Seminars, lectures and tutoring.

The language of instruction is English.

### Forms of Examination

The course will be examined through the following examination elements

- Presentation of project work, 5 credits, Grading scale: Fail (U)/Pass (G)
- Documented presentation of – and reflection in connection with – starting points, working methods and results, 2,5 credits, Grading scale: Fail (U)/Pass (G)
