#### Content

The course aims to develop the student's knowledge, understanding, and skills when it comes to the various traditions, codes, and structures of fashion by studying in both practical and theoretic terms the dominant societal tendencies and social attitudes. Furthermore, the student is trained to study and critically reflect on the relationships between the garment, the body, and the wearer. The main content of the course is:

- Introduction to fashion studies concepts
- Practical and theoretical studies on different relationships between the body and clothing in cultural, social, and structural perspectives in fashion
- Form and concept studies through practical representations and reconstructions
- Studies of and discussions about ethics and aesthetics in fashion

## **Learning Outcomes**

After completing the course, the students should be able to:

- 1. demonstrate basic knowledge and understanding of fashion studies concepts,
- 2. demonstrate knowledge and understanding of dominant fashion traditions, societal tendencies and trends, and their impact on fashion and its implications,
- 3. demonstrate the ability to practically and theoretically reflect on and analyse their own and others' design work based on different relationships between the garment, the body, and the wearer,
- 4. show understanding of different approaches to ethical and aesthetic issues in fashion.

## **Forms of Teaching**

The teaching of the course consists of lectures, practical exercises, supervision and seminars.

The language of instruction is English.

#### Forms of Examination

The course is examined through the following examination elements:

- Documented theoretical exercises (Objective 1-4) 3 credits Grading scale: Pass/Fail
- Documented design exercises (Objective 2-4) 3 credits Grading scale: Pass/Fail
