Content

The course aims to practice the ability to investigate the relationship between design principles and artistic expression through experimental design development of structural principles in relation to the body and space. The main content of the course is as follows:

- Practical studies of the definition of the body based on the aspects of space and scale
- Study of materials and structural principles
- Reinterpretation of the body through structural material experiments
- Studies of coloured light and its relation to body and space

Learning Outcomes

On completion of the course, students will be able to:

1. demonstrate an understanding of basic theories and definitions of bodily materiality by relating them to clothing through experimental design development,
2. demonstrate the ability to reinterpret and apply structural principles of function and expression applied to the body,
3. demonstrate basic knowledge of selected basic architectural construction principles,
4. demonstrate basic understanding of the characteristics of fibres and yarn types and their impact on structures in relation to scale,
5. demonstrate basic understanding of color and light impact on body and space.

Forms of Teaching

Tuition consists of lectures, seminars, exercises and supervision.

The language of instruction is English.

Forms of Examination

The course will be examined through the following examination elements:

- Documented independent creative work (Learning outcomes 1-3) 7,5 credits Grading scale: Pass/Fail
- Written exam (Learning outcomes 4) 1 credits Grading scale: Pass/Fail
- Workshop (Learning outcomes 5) 0,5 credits Grading scale: Pass/Fail
