#### Content

- Textiles, costume and the history of clothing from ancient times to the present day.
- Western clothing and textile design during the 18th to 21st centuries.
- Contemporary fashion and textile design, art and craftsmanship.
- Design and construction analysis of textiles or garments.
- Sketches and reconstruction of textiles or garments.
- Searching for information.

### **Learning Outcomes**

The course aims to provide a basic aesthetic perspective on the historical development of clothing and textiles in relation to studies of form, material and concepts by studying reconstructions, sketches and texts. After completing and passing the course, students should be able to:

- describe, relate to and reflect on the silhouettes, materials, patterns and colours used during different historical periods and their development in terms of design.
- demonstrate interdisciplinary knowledge of the history of textiles, clothing and design.
- identify the language of design of different historical periods and designers, and independently study and analyse design work through sketches, concept studies and reconstructions.

The main focus of the course is on learning outcomes: 3a-b and 4a-b.

## **Forms of Teaching**

Seminars, lectures and tutoring.

The language of instruction is Swedish. However, instruction in English may occur.

#### **Forms of Examination**

The course will be examined through the following examination elements

- Presentation of project work, 5 credits, Grading scale: Fail (U)/Pass (G)
- Documented presentation of and reflection in connection with starting points, working methods and results, 2,5 credits, Grading scale: Fail (U)/Pass (G)
