### Content

Interpretative exercises in:

- Line, direction, volume, form, texture, colour and tone in relation to the body and spaces
- Geometry, perspective and scale in 2D and 3D

Theoretical and practical studies of:

- Contrasting, shading, colour range, symbolism, impact and the industrial conditions of dyes
- The physical, thermal and chemical properties of textile materials and the industrial conditions of the material through its manufacture and standardised quality requirements

### Learning Outcomes

The course aims to train students in the basic capacity for interpretation in relation to the body and clothing through theoretical teaching and practical interpretative exercises within the form-, construction-, material- and colour-related aspects of the field of textiles and fashion. After completing and passing the course, students at first-cycle level should be able to:

- demonstrate an ability to interpret through the application and practical use of basic knowledge of textile form, colour and materials.
- demonstrate knowledge of different types of textile materials and fibres, and their properties and suitability for use within different fields of application as well as different textile testing methods.
- demonstrate knowledge of chromatistics and be able to identify, analyse and describe colours for interpretative purposes.

The main focus of the course is on learning outcomes: 1a-b, 4a-b, 5a-b, 6a-b.

### Forms of Teaching

Lectures, seminars, supervision, exercises and experiments.

The language of instruction is English.

### Forms of Examination

The course will be examined through the following examination elements:

- Assignment - color theory 3 credits Grading scale: Fail (U)/Pass (G)
- Documented independent creative work 7,5 credits Grading scale: Fail (U)/Pass (G)
- Exam, material science 4 credits Grading scale: Fail (U)/Pass (G)
- Laboratory work, material science 0,5 credits Grading scale: Fail (U)/Pass (G)
