### Content

The degree project is based on knowledge acquired from previous stages of the master's programme. It should be carried out individually or in groups of two students, ideally in cooperation with a national or international company or organisation, or with a university in an interdisciplinary context. It can also be carried out as a theoretical and empirical study of a relevant subject area covered by the master's programme in textile management with the chosen specialisation.

### Learning Outcomes

The dissertation work is the final part of the master's programme. After completing and passing the course, students should be able to:

- Use the knowledge acquired during their studies to solve tasks connected to the programme.
- Formulate, plan, structure and carry out a major project involving problem-solving, including analysis and drawing conclusions.
- Assimilate the content of relevant professional literature within the field, and incorporate the work in this context.
- Report on their degree project in a report – a master's dissertation – which meets the requirements of the programme in terms of relevance, systematics and context, scientific approach and methodology, and linguistic style and report writing. The dissertation must be of such a quality that it could be accepted for a periodical or a conference with peer review.
- Present the results orally and defend the work when opposed by other students and supervisors.
- Take a critical perspective and oppose other students' dissertations.

### Forms of Teaching

Tutoring individually and in groups in seminars, both in English and Swedish.

Presentations will be held in English.

### Forms of Examination

The course is examined on the individual performance in a written report, oral presentation and oral- and written opposition.

Course work is assessed with the grades A, B, C, D, E, Fx, or F (ECTS-grade scale) considering all goals.

The grading scale for the course is: Seven-degree grading scale (A-F).

Student rights and obligations at examination are in accordance with guidelines and rules for the University of Borås.

**Literature and Other Teaching Materials**

Literature is chosen according to the nature of the thesis and in consultation with the tutor.

**Student Influence and Evaluation**

The views of students will be canvassed systematically and regularly by means of written course assessments once courses are complete. Student representatives will work together with the Director of Studies and the course manager once a term to review courses held. **Miscellaneous**

The course is first and foremost a programme course for the Master programme in textile management with specialisation textile value chain management.
