### Content

The initial part of the course deals with basic economic theory to understand and interpret Swedish economic history in general terms. The course offers perspectives on how Sweden in a relatively short time could develop from a poor agricultural country to one of the world's richest industrial societies. The course also covers the development of economic policies such as labor market, stabilization policy, taxes and welfare.

### Learning Outcomes

After completing the course, the student should be able to:

#### *Knowledge and understanding*

- 1.1 define and explain basic concepts in economic theory,
- 1.2 describe the main features in modern Swedish economic development,

#### *Skills and abilities*

- 2.1 calculating and interpreting market equilibriums,
- 2.2 discuss the effects of different economic policies and their effects on Swedish economic development, and

#### *Judgement and approach*

- 3.1 analyse causes of economic development in Sweden over the last 150 years using theories and concepts.

### Forms of Teaching

The course is taught through lectures and seminars.

The language of instruction is English.

### Forms of Examination

The course will be examined through the following examination elements:

#### *Individual written exam*

Learning outcomes: All learning outcomes

Credits: 6

Grading scale: Seven-degree grading scale (A-F)

#### *Seminar (Group discussions on-line/physical meetings)*

Learning outcomes: All learning outcomes

Credits: 1.5

Grading scale: Fail (U) or Pass (G)

To obtain the final grade for the course, the student must pass the written exam (A-E) and the seminars (Pass). The grade obtained on the written exam then becomes equivalent to the grade given on the course.
