Prerequisites: Passed and received at least 30 credits from Master Programme (One Year) in Textile Management, of which the lowest grade received is "passed" in the course On Methodology and the Philosophy of Science in Textile Management (or equivalent knowledge).

Grading Scale: Seven-degree grading scale (A-F)

Content

The degree project is based on independent work interspersed with supervision, reporting, public discussion, examination, and defence at a final review, and presentation and posters at degree project events. The course begins with students providing a topic description that forms the basis for supervisor assignment. Subsequently, supervision takes place individually as well as a group at seminars where the work is reported on in parts, both in writing and orally. The student is to also identify research publications that are central to the academic paper's questions and theoretical reference framework during the course of the course. The work is to be discussed during a seminar where it is subjected to public discussion and examination by another student group as well as work is reported on in parts at degree project events.

Upon completion of the course, the student is to have a more deepened ability to conduct scientific studies.

- 2.1 demonstrate an in-depth skill and ability to independently plan, implement and in various forms in good English be able to present greater qualified survey work in writing and orally, where the student applies previously acquired methodology and subject skills in the field and,
- 2.2 demonstrate specialised skill and ability to independently and critically analyse and draw conclusions based on a relevant theoretical frame of reference and their own empirical studies,
- 2.3 demonstrate specialised skill and ability to be able in writing and orally to reflect and discuss other students' works in progress,

Forms of Teaching

Individual supervision, group supervision, and seminars.

The language of instruction is English. However, instruction in Swedish may occur.

For a passing grade on the course, all components within the course must receive a passing grade. The academic paper is the basis for the final grade (A-F). The other components are pass/fail.

The student is offered a total of five (5) examination opportunities and examination is offered on three (3) occasions per year. The student's rights and obligations regarding examination are in accordance with guidelines and regulations in place at the University of Borås.

If the student has received a decision/recommendation regarding special pedagogical support from the University of Borås due to disability or special needs, the examiner has the right to make accommodations when it comes to examination. The examiner must, based on the objectives of the course syllabus, determine whether the examination can be adapted in accordance with the decision/recommendation.

Student rights and obligations at examination are in accordance with guidelines and rules for the University of Borås.

Literature and Other Teaching Methods

Literature is chosen with relevance to the student's degree project. The supervisor can be helpful in this process; however, the student has the primary responsibility for the literature search.

Student Influence and Evaluation

The course is evaluated in accordance with current guidelines for course evaluations at the University of Borås in which students' views are gathered. The course evaluation report is published and returned to participating and prospective students in accordance with the above-mentioned guidelines, and will be taken into consideration in the future development of courses and education programmes.

Course coordinators are responsible for ensuring that the evaluations are conducted as described above.

The course is part of the following programme: Master Programme (One Year) in Textile Management.
