## Content

The course aims to develop knowledge about different traditions within clothing and fashion by studying both dominant international perspectives and specific geographical perspectives. Students will also be trained in their ability to describe and critically discuss their own work based on the various perspectives discussed during the course. The main content of the course is as follows:

- Introduction to fashion science concepts
- Review, discussion and presentation of the relationships between the body and clothing, studied through global and local, historic and contemporary perspectives on fashion, clothing and the body through practical work
- Form and concept studies through representations and reconstructions through practical work
- Analysis and interpretation of students' own design work with reference to contemporary experimental and professional practitioners and forms of presentation

## Learning Outcomes

After completing the course, students should be able to:

- 1. demonstrate basic knowledge and understanding of the dominant international and specific geographical fashion traditions based on theoretical, artistic and practice-based perspectives through practical work,
- 2. analyse their own work and that of others based on a specific perspective within fashion design through practical work and in writing,
- 3. position and reflect on their own design work in relation to experimental and professional design practice and its social implications.

## Forms of Teaching

Tuition consists of lectures, group work, seminars, supervision and exercises.

The language of instruction is English.

The course will be examined through the following examination elements:
